## **Background**

Article V, Section 4, "Selection and Tenure," of the Auxiliary Programs Corporation Bylaws designates the college superintendent/president and chief financial officer as ex-officio voting directors of the corporation. The other three directors shall be selected as follows: one (1) academic administrator appointed by the superintendent/president; one (1) regular faculty member nominated by the Academic Senate and appointed by the superintendent/president; and one (1) student member nominated by the Associated Student Body Government and appointed by the superintendent/president. In addition, one (1) college trustee serves as a non-voting director.

- The superintendent/president reappoints Dr. Robert Curry, associate superintendent/vice president, academic affairs, to serve as the academic administrator for 2019.
- On a nomination from the Academic Senate, the superintendent/president reappoints Andrea Sanders to serve as the faculty member for 2019.
- On a nomination from the Associated Student Body Government, the superintendent/president reappoints Inri Serrano to serve as the student member for the remainder of the academic year 2018-19.
- At its December 11, 2018 meeting, the Allan Hancock College Board of Trustees reappointed Jeffery Hall to serve as the non-voting trustee director for 2019.

# 4. Information

4.a. Financial Report for Auxiliary Programs

Keli Seyfert provided a summary of the financial report for ASB and Athletics. There was a brief discussion about the expenses associated with hosting the football championship game.

# 4.b. Oral Reports

Mark Booher reported *Peter Pan* has met 95 percent of its revenue goal, with an internal goal to be at 100 percent by the end of November. He noted *Peter Pan* was an expensive production and shared some of the expenses associated with the flying component of the production. Dr. Walthers inquired about the number of shows available for *Peter Pan* and asked about the noise control of the flying mechanisms during the program. Mr. Booher and Jennifer Schwartz indicated there were possibly two fewer shows scheduled and many student matinee shows do not appear on the public calendar. Mr. Booher also explained that the flying mechanisms can be heard, noting sometimes it can depend on the technician that is operating the equipment and the musical scoring in the program that may or may not mask the sounds of the equipment during the show.

Mr. Booher provided a staffing update of new staff members and vacant positions. He shared they are beginning summer design meetings and planning for the next season.

Jennifer Schwartz reported *Mamma Mia!* and *Peter Pan* may be the only two shows to meet their goals. *Mamma Mia!* did very well and made up for some summer shows that did not meet their goal. She shared there are big goals for *Shakespeare In Love* and *A Gentleman's Guide*, and noted *The Wolves* is also doing well and on track to reach goal.

Kim Ensing acknowledged the \$7,500 sponsorship from Home Motors which will offset the awards for the players of the football championship bowl game. She announced there will be a toy drive at the Toys for Tots women's basketball tournament and reviewed upcoming athletic events.

Mark Booher shared that Kim Ensing has also been working with Kitty Balay, resident artist/director of engagement, around the production of *The Wolves*. They have created a recruitment event for Hancock soccer that will link to a performance of *The Wolves*.

Ms. Ensing reported there will be a football championship ring ceremony on February 16, 2019 during a basketball game to recognize the football student athletes. The event will increase attendance for the basketball game as well.

Ms. Ensing noted the persistence rate for the English/speech class pilot program has been phenomenal. She shared a student athlete's experience with the pilot program. Ms. Sanders added the program has been good and said that she and Rob Senior put a lot of time into the program and feel the pilot program has been very successful.
